- b. Abbey: April is Invasive Plant Pest and Disease Awareness Month. Friday 3/31 there will be a new and turnkey Action Kit released via Hungry Pests with social media ideas, press release, customizable promo materials, pest cards, and other outreach tools for widespread use. - c. Tricia: Hungry Pests materials with Vin Vasive have been outstanding resources for her needs in Illinois. She stated the new Invasive Plant Pest and Disease Awareness Month Action Kit should also be very useful for Illinois Invasive Species Month (held each May).
- d. Leigh: Central Plant Board in April will have a presentation by Leigh, Dave Hirsch (SPHD of ND/SD) and Charles Elhard (ND Dept of Ag) to describe ad hoc interagency working group that formed to address firewood movement to Dakota Access Pipeline protest encampment in 2016-2017.
