# CONTINENTAL DIALOGUE ON NON-NATIVE FOREST INSECTS & DISEASES NINTH DIALOGUE MEETING NOVEMBER 4-5, 2013

# **Meeting Summary**

On November 4-5, 2013, a diverse group of approximately 36 representatives from state and federal agencies; private business and industry; academia; and non-governmental organizations gathered at the Pittsburgh Convention Center for the ninth annual meeting of the Continental Dialogue on Non-Native Forest Insects and Diseases (the Dialogue). This meeting was held in conjunction with the Arbor Day Foundation's Partners in Community Forestry Conference, which took place at the Pittsburgh Convention Center on November 6-7, 2013.

The Dialogue's ninth annual meeting was planned and convened by the Dialogue Steering Committee, a cross-section of stakeholders with an interest in protecting forests from the threat of non-native insects and diseases. #### I. Meeting Objectives

The purpose of this meeting was to advance collaboration around actions to address the threat of nonnative forest insects and diseases. Specific objectives included:

- cultivate collaborations toward action to address the threat of non-native forest insects and diseases;
- expand the effectiveness and reach of public and private entities and citizens in the battle against the non-native insects and diseases killing their trees; and
- identify and seek consensus on needed actions for major initiatives the Continental Dialogue will advance in the upcoming year.

#### II. Welcome and Introductions

Facilitator Dana Goodson, RESOLVE, welcomed the participants to the meeting on behalf of the Dialogue's Steering Committee. Ms. Goodson briefly reviewed the materials provided to meeting participants and then provided an overview of the agenda and meeting ground rules.

# VIII. Breakout Sessions

The participants broke into a number of smaller discussion sessions. Following these breakout sessions, the group reconvened in plenary to hear brief reports on each breakout and specifically the next steps they planned to take.

# Initiative Breakout Session I (Concurrent Sessions)

Establishing collaborative priorities for invasive species management – Michael Buck, NASF

<u>Takeaways:</u> Federal agencies are struggling with how to establish budget priorities in a time of declining resources. There might be a role for the Dialogue in helping to organize a cross-agency or multi-stakeholder conversation on the issue of priorities for invasive species management.

#### Possible Dialogue activities:

- o Hold a workshop focused on developing a strategic framework for setting priorities
- Invite the "users" of invasive species management funding to discuss priorities

- Identify frameworks for priority-setting that are used elsewhere
- UFORHIC (Urban Forest Health Information Center) project and update on phone applications/citizen science tools; follow-up to meeting hosted by APHIS in May – Eileen Luke, Purdue University; Scott Maco, Davey Institute; and Bill Toomey, Forest Health Protection Program Director, The Nature Conservancy

<u>Takeaways</u>: More can be done to build on, disseminate, and make accessible the UFORHIC platform for forest data as well as apps and other tools for citizen scientists.

#### Possible Dialogue activities:

- Ensure relevant data is included in the UFORHIC database
- Make the data exchangeable
- Use Dialogue members' networks to promote tools

#### Initiative Breakout Session II (Concurrent Sessions)

• Firewood Outreach and Firewood Industry Labeling Efforts - Leigh Greenwood, The Nature Conservancy and Geoff Friedman, American Firewood Producers and Distributors Association

<u>Takeaways:</u> Building on the "Don't Move Firewood" message, the Dialogue could have a role in promoting the idea of distributing free firewood at parks and campgrounds.

#### Possible Dialogue actions:

- o Develop case studies, survey data, or a position paper around the idea of free firewood
- Offer assistance to the Canadian Food Inspection Agency in developing a "Don't Move Firewood"-based domestic policy
- Healthy Trees, Healthy Cities: Integration and Next Steps Rachel Holmes and Bill Toomey,
   Forest Health Protection Program, The Nature Conservancy

<u>Takeaways:</u> Participants felt the Healthy Trees, Healthy Cities approach is a good one and that it is important to consider the different geographies of different areas. They also identified synergies between this program and other efforts, which suggest a potential for mutual reinforcement.

#### Possible Dialogue actions:

- o Identify overlapping interests with other programs by overlaying the criteria for "hot spots"
- o Promote messages related to biodiversity and urban forest planning
- Proactive Outreach and Communication Faith Campbell, The Nature Conservancy

<u>Takeaways:</u> There is a lot of member interest in the Dialogue undertaking outreach and communication activities, and the breakout participants identified several key areas where the Dialogue could be most useful.

#### Possible Dialogue actions:

- Develop a repository for school-based educational materials
- Highlight the efforts of companies that are leading the way on good practices in wood packaging
- Develop a set of fact sheets on non-native forest insects & diseases using data available due in part to past Dialogue activities; some of the fact sheets could be focused on individual states. These fact sheets could be used in meetings with policymakers.

# IX. Summary and Next Steps

Ms. Goodson reminded the group that the Dialogue Steering Committee would meet directly after the plenary adjourned in order to set the Dialogue's priorities for the coming year, drawing upon the options discussed in the plenary meeting. All members were invited to sit in on the Steering Committee meeting. The committee's decisions on priority actions will be shared with the full Dialogue participant list.

Mr. Toomey concluded the meeting by thanking the group for their participation, the presenters for sharing their knowledge, and the Steering Committee's planning group for coordinating the meeting. He expressed the hope that the attendees found the meeting valuable, and will continue to remain engaged with the Dialogue.
