



## ENVIRONMENTAL PRODUCT DECLARATION: WOOD PALLETS





Product Category Rule (PCR) for Wooden Pallets Published June 2019



The Environmental Product Declaration (EPD) is an environmental certification that quantifies and verifies the life cycle of products. Requires a PCR, LCI, and LCA and ISO 14025, 14040.

EPDs help customers make the best decisions when choosing goods or services among different providers. Finalized by Mid-2020




# LANDFILL AVOIDANCE WOOD PACKAGING MOST RECYCLED PACKAGING PRODUCT
